TERMS AND CONDITIONS

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents aged 21 years or over who can travel for the 2025 American Football Season (between Sep-Dec 2025).
- 3. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter.
